



PLUG. PACK. PUFF.

- 1. Charge your AirvapeX using the enclosed cable. Insert charging cable with USB logo facing up! Inserting the cable the opposite way can damage the port.
- 2. Pack the chamber lightly. It is recommended that you grind your herbs before packing the chamber.
- 3. Press the power button 3 times quickly to turn the device on/off. Adjust temperature using the up and down buttons. Vibration indicates readiness.
- Inhale through the mouth piece and enjoy. You do not need to hold down any buttons in order to inhale.
- 5. The safety shutoff timer will automatically turn the unit off after 3 minutes. You can also choose to turn the unit off at any time by pressing the power button 3 times.





TIPS & TRICKS

- Use the brush to clean the chamber after each use, while device is still warm.
- 2. Change F°/C° by holding down the power button and pressing the "down" button.
- Change auto turn-off time by holding down the power button and pressing the "up" button.

5. Cleaning and Shipping.

When sending the Product to us for warranty service, please follow this procedure to clean your unit to ensure your warranty will remain valid and enforceable.
